If none, (b) Highest certified current average as of the tournament date (min. of 15 games). If none, (c) Bowl scratch (210) – No league sheet necessary.

*Rule 319c will apply. The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. It is the bowler's responsibility to provide average verification for the handicap division. Any falsification of the highest known average will result in immediate disqualification. All standing sheets must be received and verified by the end of the last squad of the District Finals. Failure to provide this information will result in the bowler receiving "210" for their average. Sole certified "sport" averages will be adjusted.*

- District Directors will process and verify all paperwork. Centers will be scheduled on a first come, first serve basis.
- Final level of competition for the 11-under division earning scholarships based on a ratio of **at least 1:8 per division.**
- The 12-up divisions are competing for scholarships and advancement to the State Finals based on a ratio of **at least 1:5 per division. One-time entry.**FORMAT** One (6) game qualifying block moving pairs after each game. After all squads are completed, the overall top four bowlers in each division (16 bowlers total) will qualify for the stepladder roll-offs\*. (*\*Determines berths & scholarship placement.*)**AVERAGES** (a) Highest certified league average (min. of 15 games), dated as of April 15, 2010. If none, (b) Highest certified current league average (min. of 15 games) closest to competition date. If none, (c) Bowl scratch (210) – No league sheet necessary.

*Rule 319c will apply. The average of a bowler may be adjusted upward before participation in any event. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. It is the bowler's responsibility to provide average verification for the handicap division. Any falsification of the highest known average will result in immediate disqualification. All standing sheets must be received and verified by the end of the last squad of the District Finals. Failure to provide this information will result in the bowler receiving "210" for their average. Sole certified "sport" averages will be adjusted.*

- **State Qualifiers MUST RSVP their squad choice online at [www.CalUSBC.com](http://www.CalUSBC.com) in order to participate.** Instructions are printed on the District Finals recap and on the back of this sheet. **DO NOT CALL FOUNTAIN BOWL WITH ANY QUESTIONS.**
- The 12-up Handicap Divisions are competing for scholarships based on ratio of 1:8 as well as the final top two (2 boys/2 girls) will earn a FREE entry into the CA State Youth Championships in North County USBC (July 2010).
- The final top two (2 boys/2 girls) in the 12-up Scratch Division will earn a FREE entry plus a travel stipend into the 2010 USBC USA Jr. Gold National Championships (**July 2010**) in Indianapolis, Indiana. (*See State Rules*).

# Pepsi State Finalist Information – 12-UP DIVISIONS ONLY QUALIFYING & REGISTRATION INSTRUCTIONS

For bowlers that have qualified from the District Finals to the State Finals. Must be at least 12 years old as of August 1, 2009 in order to participate.

**RSVP Window: MARCH 30-APRIL 5, 2010 • State Finals: MAY 1-2, 2010**

**STATE FINALS QUALIFIERS:** State Finalists (12-up only) will qualify from District to State based on a ratio of 1:5 per division and will be notified before the RSVP window. Qualifiers will also be posted online at [www.CalUSBC.com](http://www.CalUSBC.com). All state finalists are competing for scholarships. The 12-up divisions will earn scholarships at the State Finals (MAY 1-2, 2010 at FOUNTAIN BOWL) as well as vying for berths into either the USBC USA Jr. Gold National Finals (Scratch division) or the CUSBC CA State Youth Championships (Handicap division) in North San Diego County.

**Please read the tournament rules carefully. YOU MUST REGISTER YOUR SQUAD CHOICE IN ORDER TO BOWL IN THE STATE FINALS.**

**FORMAT:** FREE one-time entry. Qualifiers select one squad, which consists of (6) games of qualifying moving pairs after each game. After all squads are completed, the overall top (4) bowlers from each division (16 bowlers total) will qualify to the **stepladder roll-off\*\*** held immediately after the last squad on Sunday. **PLAN YOUR SQUAD CHOICE CAREFULLY.** Space is limited and filled on a first come, first serve basis. (Be aware that if you bowl on Saturday, you may have to come back for the stepladder roll-offs on Sunday. It will be **YOUR RESPONSIBILITY** to check the standings after each squad to see if you are in the top four cut. \*\*The Stepladder roll-off determines scholarship placement per division and berths.
